From the Podium

Our April meeting was well attended and our guest speakers, Sheila Hallinan the Executive Assistant at the Secretary of State's Office of Public Engagement and Betty Kuffel Secretary of State Homebound Program from the Illinois Secretary of State's office were well received. The Homebound Program is a service program for older adults, bedridden individuals and people with disabilities who are unable to leave their homes to obtain a state ID card from a Secretary of State facility. The card may be used for identification purposes in the same way as a standard driver's license is used for identification.

Certain documents are required to obtain the card. Once an applicant submits the information via our web form, The Homebound Program office will determine eligibility, and the documents required to complete the transaction. For assistance to help determine if you or your loved one qualifies for this service, call 312-814-3121.

We learned about the REAL ID requirements and uses. Beginning May 7, 2025, the federal government will require every person 18 years and older to present a REAL ID-compliant state-issued driver's license or ID card or another acceptable form of identification - like a valid U.S. passport - to board a flight within the U.S. or enter a secure federal building. This does not mean that you must rush out to get a REAL ID driver's license or a REAL ID State ID card. If you have no plans to travel via airplane soon or at all or if you have a current passport there is no hurry for you to get one. More information is available at <https://realid.ilsos.gov/>. 
SCAM ALERT

Watch out! Scammers target everyone.



Recognize scammers. They may:

- **PRETEND** to be from an agency or organization you know.
- Say there's a **PROBLEM** or promise a prize.
- **PRESSURE** you to act immediately.
- Tell you to **PAY** in a specific way.



Do not give scammers money or personal information – Ignore them!

How to avoid a scam:

- **Remain calm.** Talk to someone you trust.
- **Hang up or ignore** the message. **DO NOT** click on links or attachments.
- **Protect your money.** Criminals will insist that you pay in a hard-to-trace manner, such as with a gift card, prepaid debit card, cryptocurrency, wire transfer, money transfer, or by mailing cash.
- **Protect your personal information.** Be skeptical of a contact you didn't initiate.
- **Spread the word.** Share your knowledge of Social Security-related scams. Post on social media using the hashtag #SlamtheScam to share your experience and warn others. Visit ssa.gov/scam for more information. Please also share with your friends and family.
