February 8th 2017 Speaker

Our speaker David Barrett is an attorney from Cooney & Conway Law Firm. He spoke of the dangers of mesothelioma, a disease caused by asbestos. Construction workers are exposed to asbestos on the job and can be affected. Yet in some cases it could take decades before someone exposed to asbestos will get the disease. When the illness strikes signs are fluid around the lungs abdomen and heart.

No warning of this product is considered negligence. More and more cases are occurring each year. It's a progressive disease that gets diagnosed at greater numbers over time. The average age of those stricken is 72 and a great deal of those are in Cook County.

There are fifty or sixty trust funds for future asbestos litigation and one may have to go back in a career 40 years to acquire evidence of exposure.

Sometimes there is no information.

Spray insulation is a potent form of asbestos and many electricians working in the ceilings where this was used have been exposed. There is a statute of limitations. There is a Cook County criterion that must be met to file suit.

RECIPE EXCHANGE

I receive this recipe from Laura Felde and if it's as good as the butternut squash soup, I know it will be good. I received raves about the Butternut Squash soup.

Slow Cooker Stuffed Pepper Soup

1 lb. Lean ground beef or ground turkey 3/4 tsp. Salt

1 cup chopped onion

2/3 cup chopped green pepper

2/3 cup chopped red pepper

3 garlic cloves, chopped

2 cups gluten free reduced sodium chicken broth

2-14.5 ounce cans petite diced tomatoes 1&3/4 cups canned tomato sauce

1/2 tsp. Dried marjoram

Freshly ground pepper

3 cups cooked brown rice

Heat a large skillet over high heat. Add the ground beef and salt. Cook while breaking the meat into pieces as it browns in about 4 or 5 minutes. Put meat into slow cooker. Drain the fat from skillet. Return the skillet to medium-low, heat and add the onion, bell pepper and garlic. Cook and stir until soft about 6 to 8 minutes. Transfer to slow cooker and add tomatoes, tomato sauce, marjoram and black pepper to taste. Cover and cook on high 4 hrs or low 8 hrs. Cook rice. Ladle the soup into 6 serving bowls and top each with 1/2 cup of cooked brown rice. Serve hot.
