She also discussed Mail order drugs and generics, both of which can save you a lot of money. Chiropractic treatment covered for 30 visits and hearing aids with the preferred provider being True Hearing. You can check with EIT or your health care manual for information. There were

RECIPE EXCHANGE

Cinnamon Doughnut Muffins

1-3/4 cups flour

1-1/2 tsp baking powder

½ tsp salt

½ tsp ground nutmeg

1/4 ground cinnamon

3/4 cup sugar

1/3 cup oil

1 large egg, lightly beaten

3/4 cup milk

10 teaspoons strawberry or your favorite jam

TOPPING:

1/4 cup butter, melted

1/3 cup sugar

1 tsp ground cinnamon

In a large bowl, combine flour, baking powder, salt, nutmeg and cinnamon. In a small bowl, combine sugar, oil, egg and milk; stir into dry ingredients just until moistened. Fill greased or paper lined muffin cups half full; place 1 teaspoon jam on top. Cover jam with enough batter to fill muffin cups ¾ full. Bake at 350 degrees for 20-25 until a toothpick comes out clean. Place melted butter in a small bowl; combine sugar and cinnamon in another bowl. Immediately after removing muffins from the oven, dip tops

in butter then in cinnamon-sugar. Serve warm.

Yield: 10 standard size muffins.


