Saving the ACA

Donald Trump and the Republican Party have been trying their best to repeal the Affordable Care Act (ACA). Thank goodness they've failed. Let's look at the consequences of their actions if they should succeed. According to the Congressional Budget Office (CBO), a bi-partisan office of the federal government, approximately 29.8 million Americans would lose their health insurance if the ACA were to be repealed. This would more than double the number of people currently without insurance. Further consequences of the Trump administration's cold-hearted actions could mean the loss of 1.2 million jobs in health care and collateral occupations.

They will soon try again to repeal the ACA.

I know you have heard that the ACA is imploding and cannot sustain itself and that insurance companies are abandoning large areas of the country. All I can say is that's FAKE NEWS. At this writing, it has been reported that every county in the country is being covered. The Ohio Department of Insurance announced on August 24, 2017 that CareSource has agreed to offer exchange coverage in Paulding County, Ohio-the last county in the country is now covered. September 13, 2017 Speaker

Our speaker was Joe Ziemba, a football author and historian. Joe wrote a book titled "When Football Was Football", this basically took the reader back to the very early days of no helmet or leather helmet. times when guys got together to have semiorganized mayhem.

Joes father played for Mt. Carmel, Notre Dame (?), and the Chicago Cardinals. Joe provided not just the history of football, predominantly, the Cardinals, but also with many antidotes and much humor.

Early football history; the first game was played in 1889, they were neighborhood games basically. Rules were 3 downs, 110 yard field, no passing because the ball was rounder, and at the end zone it was legal to take the smallest player on the team and throw him over to score. The wedge was also legal at that time. By 1905 some schools that had teams began to drop the sport due to injury and deaths. The president at the time, Theodore Roosevelt stepped in and together with the schools formed the NCAA, and began formalizing rules that were adopted both at the college and the early professional teams.

One bit of a side note, in 1900 the Morgan Park Athletic Assn. had a gentleman by the name of Frank Reagan on the team. Frank was a union organizer for the gas workers. Now it is said, according to Joe, that at a later date some of this association became aligned with another association headed by a Mr. Al Capone.

In 1920 the forerunner to the NFL the Cardinals invited Jim Thorpe to play for them. In 1921 Paddy Driscoll was the Capitan and coach. In 1925 the Bears had Red Grange and the two teams played at Comiskey Park, the bears lost 6-0 and a fight broke out that the police had to breakup. In 1947 the Cardinals won the Championship 28-21. 1948 they lost 7-0. Joe pointed out that the Cardinals played in

Chicago both at Comiskey Park and Wrigley Field until they moved to St. Louis in 1960. this was due to TV rules at the time. In 1988 they became the Phoenix Cardinals, and in 1994 they became the Arizona Cardinals.

Some did you know facts that Joe said.

- 1. The Cardinals are the oldest NFL team;
- 2. At one time Jack Daniels played for them
- 3. 1955 They drafted Joe Namath #1 he didn't sign.
- 4. Today the team is worth in excess of \$1.5Billion. Rich Sipple

Local 134 Office Manager Tim Fitzgibbons was at our meeting and spoke to us about the retiree's contributing to the health insurance benefit. Those of us born in 1938 or before are not included in the payment plan. Those of us who turn 80 and older after January 1, 2018 will pay half of the monthly payment each year of the plan. Tim said they're negotiating for more than 360 days of health insurance for widows of retirees. He said the Electrical Insurance Trustees will be leaving the LaSalle Street address, because of the high rent. Tim also encouraged the retirees to sign up for picket duty. We must be physically able and picket duty could last six hours, it pays \$125.00 per day. The Retiree's Club wants to thank Tim for taking time from his busy day to speak to us.


